Additional instructions may be issued subject to the NCR of the Motorsport Australia Manual.

This Event will be conducted under and in accordance with Motorsport Australia OH&S, Motorsport Australia Safety 1st and Legal and Integrity Risk Management Policies, which can be found on the Motorsport Australia website at www.motorsport.org.au

- (b) Entries must be completed online in Motorsport Australia MSA online entry portal system.
- (c) The Entry fee will be \$100.00
- (d) The maximum number of entries may limited to 90 Competitors. Acceptance of entries will be in order of receipt
- (e) Entries may be refused in accordance with the NCR.

3. ELIGIBILITY OF COMPETITORS. Persons eligible to compete are the Competitors and Drivers who are members of M.G. Car Club of Queensland Inc or other Motorsport Australia affiliated club.

Relief Drivers are not allowed on dual entries.

MINIMUM LICENCES: Current Motorsport Australia Speed/Speed Junior, or above, club membership and Motorsport Australia vehicle Log Book (if issued)

NOTE: All Queensland road registered cars (Trade Plates are not acceptable) must have an <u>original</u> 3rd Party extension certificate on their current Qld Transport Registration provided by the 3rd Party insurer, specifically covering the days of each competition. <u>Email certificate to mgccq@mgcc.org.au prior to the Event.</u>

4. STARTING TIME Official timed runs will commence at 10.00 on Saturday 8th September 2024 unless otherwise notified in Further Regulations. Running order will be as published.

5. SCRUTINY TIME AND PLACE

Scrutiny will be conducted at this event. Scrutiny will start at the Scrutiny Bay from 7.00 am on Sunday 8th Competitor Licence check will be done prior to the Event via the Motorsport Australia Portal Please take your log book, copy of Third Party Extension if applicable club membership card, Self-Scrutiny checklist and Self Statement of Vehicle Compliance forms to the secretary's office prior to Scrutiny.

- (a) Helmets, goggles or visors fire extinguishers' and seat belts must be Motorsport Australia approved.
 Apparel Schedule D of the Motorsport Australia Manual (Includes Helmets).
 Seat Belts Schedule I of the Motorsport Australia Manual (Includes Head restraints).
- Any competition vehicle with a fitted roll cage (MSA log booked or not) shall comply with Schedule D (b) Parc Ferme is the area covered by the scrutineering roofed area.
- (c) The Chief Scrutineer or his nominee shall be the Judge of Fact in all matters pertaining to the safety of a vehicle, equipment or clothing.
- **6. DRIVERS BRIEFING:** Drivers Briefing may be 9.45 am Saturday of the competition at the Scrutiny shed. Any changes will be advised by the Public Address system.
- 7. COMPETITION: All Competitors shall be ranked in accordance to their fastest recorded time. These times will go towards the annual points for the Interclub Challenge and individual club awards. ICC trophies will be presented at the end of year celebrations.

8. APPAREL:

All apparel including helmets must comply with the Schedule of the Motorsport Australia Manual.

9. VEHICLES:

All vehicles shall comply with Technical Appendix Schedule A and B of the Motorsport Australia Manual.

10. GENERAL:

- (a) The Organiser reserves the right to abandon, postpone or stop the Event in accordance with the NCR.
- (b) Competitors permanent racing numbers will be allocated where possible. Competitors must use the number shown on the official list of entries. **This number must be displayed on both sides of the vehicle in a professional manner.**
- (c) Protests must be lodged in accordance with the NCR.

(d) ACCESS TO TIMING SHED AND TRACK:

The timing shed shall be out of bounds to all except those in an official capacity. Should it be necessary for a Competitor to speak to an Official, they may come to the back door but must remain outside until a necessary Official attends to them.

Competitors/ Pit Crews/Spectators are not allowed on the circuit when there is an on track accident

(e) ALL AUTOMOBILES MUST BE FITTED WITH AN EFFICIENT MUFFLER TO LIMIT NOISE BELOW 95dB.

Noise readings will be taken during the first run and randomly thereafter. Cars exceeding the 95dB limit will only be given one opportunity to modify their exhaust before continuing. If the vehicle exceeds the noise limit a second time *they will be disqualified from the Event*. For any run in which the noise limit is exceeded, no time will be recorded. (NLE – Noise Limit Exceeded). Judges of Fact for the noise measurements will be the appointed Sound Monitor, Chief Scrutineer and Clerk of the Course.

- (f) Fuel shall comply with the Schedule of the Motorsport Australia Manual.
- (g) **Fire Extinguishers**: It is a condition of entry that Competitors agree to pay all costs incurred by the MG Car Club of Qld. Inc. for the use of any fire fighting equipment on any vehicles used /operated by the Driver/Drivers Pit Crew.
- (h) **Timing Gear**: Drivers may be asked to make restitution for any damage caused by them to the timing gear.

(i) INTEGRITY

Smoking (which includes e-cigarettes and "vaping") and any naked flame is prohibited within the pit area. Designated Smoking is the area adjacent to the Stewards covered patio located between the Toilets and the Timing Shed. Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy. Motorsport Australia's Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at www.motorsport.org.au.

Any Participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia. Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.

(j) ABUSIVE & DISRESPECTFUL BEHAVIOUR.

As an Entrant competing in this event if you experience, or see, or hear, any aspect of this type of behaviour - SPEAK UP & CONFIDENTIALLY CONTACT the Event Secretary at the Administration Office, in the knowledge that it is our collective responsibility to build a "Motorsport Environment of Respect for All" including our Organisers, Entrants, Crew, Officials, and members of the attending public.

- (k) Speed Limit in Pits 10 kph, penalties may be applied if directions given by Officials are not followed.
- (I) Driving around the Pits to warm up cars or registered cars leaving the circuit to warm up cars is prohibited.
- (m) Track boundary marker cones incur 5 second penalty each if dislodged.
- (n) False Starts: Once the beam has been broken, the run is deemed to have begun. A pushback restart will not be allowed. No artificial means of holding the vehicle on the start line will be permitted. Pit crew members are not allowed past the Armco onto the start pad unless directed.
- (o) Results will be published on the Club website www.mgccq.org.au within the required 72 hours. Those requiring mailed results should advise the Event Secretary accordingly.
- (p) Marques and tarps must be securely fastened to the ground.

11. INSURANCE

Certain public property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the Event. Further details can be found in the Motorsport Australia Insurance Handbook, available at www.motorsport.org.au
